

#### Official Statement Issued by Ummet Waqf

#### Regarding the Allegations Circulating on Social Media

In the Name of Allah, the Most Merciful, the Most Compassionate

Dear donors and esteemed supporters,

In recent days, social media platforms have witnessed an organized and coordinated campaign targeting Ummet Waqf with a number of entirely unfounded accusations and fabricated claims. In the face of this misinformation, we find it necessary to respond clearly, firmly, and professionally — to expose the falsehoods being circulated and reaffirm the transparency, integrity, and legal accountability of our work.

#### We state unequivocally:

Ummet Waqf is completely innocent of all allegations.

Our record is clear, publicly accessible, and under continuous official oversight.

# 1. Findings of the Official Inspection

The allegations and so-called "secret reports" circulated online have already been addressed through an official investigation conducted by the General Directorate of Foundations in the Republic of Türkiye.

The formal inspection report, which is publicly available and attached, categorically refutes every claim point by point, supported by verified and documented evidence.

This report stands as the highest authoritative confirmation of the Waqf's integrity, transparency, and full compliance with all legal obligations.

#### 2. Legal Status and Oversight

Ummet Waqf was established on 21 October 2013 under Deed No. 35787. It is a fully Turkish foundation in origin, administration, and governance, operating under the direct supervision and continuous monitoring of the General Directorate of Foundations.

This clear legal framework eliminates any attempt to misrepresent or distort the Waqf's identity, nature, or affiliation.

#### 3. Complete Independence from Groups and Political Actors

Since its establishment, Ummet Waqf has maintained no relationship or affiliation — direct or indirect — with any group, party, or political movement, whether inside or outside Türkiye.

The Waqf is entirely independent, guided by a Turkish administrative structure, and strictly adheres to all regulatory requirements governing foundations in Türkiye.

Regular audits by competent authorities ensure the highest possible levels of transparency and accountability.

## 4. Evidence from Thousands of Publicly Documented Projects

The thousands of humanitarian, educational, and developmental projects implemented by Ummet Waqf in AL QUDS, Gaza, Syria, and other regions — all documented on our official platforms and in detailed public reports — form a proven and undeniable record of real impact.

These achievements represent the strongest response to every false allegation. Those who fabricate such claims cannot begin to grasp the scale of the continuous work being carried out for the people of AL QUDS, Gaza, and Palestine at large.
